## BEA CONSTITUTION – UPDATE AND REFRESH

The BEA executive has engaged Governology Pty Ltd to assist with drafting a new constitution and conversion to Company Limited by Guarantee.

### **Background.**

- The BEA is currently an incorporated association pursuant to the Associations Incorporation Act 1991 (ACT).
- The BEA is seeking to transfer its legal structure from an Australian Capital Territory incorporated association to a company limited by guarantee pursuant to the Corporations Act 2001 (Cth).
- This process requires the development of a new constitution fit for a company limited by guarantee, approval by members of the new constitution and transfer of incorporation and subsequent application to the relevant regulators.

The BEA council met for a workshop led by Governology on 11 December 2025 to inform the briefing paper for Governology to enact when developing the proposed new constitution.

Further details will be shared with affiliate members closer to the 2026 AGM where the new, proposed constitution will be voted on by affiliates.
